CIVIC GOVERNMENT (SCOTLAND) ACT 1982

STREET TRADER'S LICENCE STANDARD CONDITIONS

1. The street trading which is permitted under this Licence is as follows:-
 - (a) *(articles for sale)*
 - (b) Trading is permitted between the hours of *(Hours permitted to trade)*
 - (c) Trading is permitted *(location)*
2. The Licenceholder is prohibited from trading within 150 metres as the crow flies of any other the same or similar class and description as those to be sold or offered for sale by the Licenceholder.
3. The Licenceholder is prohibited from trading within 500 metres of any school premises at any time when the premises are open for use as an educational establishment.
4. Unless specifically permitted to trade at a particular stance detailed in Condition 1 above, the Licenceholder is only permitted to trade at any stance or stopping point for a period not exceeding twenty minutes at any one time.
5. The Licenceholder is only permitted to trade under this licence when (1) during those times when the Licenceholder is trading on a public road, the Licenceholder is trading from either a self-propelled vehicle or a trailer which is designed to be hitched to a towing motor vehicle or (2) when the Licenceholder has a valid planning consent for the site on which the Licenceholder is trading.
6. The Licence holder must modulate any noise (including amplified music) caused by him in connection with street trading to the satisfaction of the Council and must comply with all instructions made by the Council's Head of Legal & Property Services, Head of Safer Communities or other Authorised Officers with a view to minimising or avoiding nuisance or annoyance to the general public.
7. On each occasion when the Licence holder has completed trading at any stance, he shall clear away and uplift all litter and similar material from the stance and arrange for its disposal by the refuse collection services.
8. The Licence holder shall at all times when engaged in street trading, wear or otherwise display on his person the identity card issued by the Council in connection with this Licence. The Licenceholder must not alter or deface the licence or identity card in any way.
9. If the Licence holder loses the Licence, identity card, Certificate of Compliance or any other document issued by the Council in connection with his street trading, he shall immediately intimate in writing such loss to the Head of Legal & Property Services, Municipal Buildings, Greenock, and shall obtain a duplicate of each lost document on payment of the requisite fee.
10. Where this licence is issued for an activity which -
 - (a) consists of or includes food business within the meaning of Section 1 of the Food Safety Act 1990 or of Regulations made under Section 16 of the said Act.
 - (b) involves the use of a vehicle, kiosk or moveable stall,

there must be in relation to such vehicle, kiosk or moveable stall a certificate issued by the Head of Safer Communities (hereinafter called a "Certificate of Compliance") stating that such vehicle, kiosk or moveable stall complies with the requirements of any relevant Regulations made under the said Section of the said Act and such Certificates of Compliance must be kept on public display within such vehicle, kiosk or moveable stall whenever street trading is being carried out.

It is wholly the responsibility of the Licenceholder to ensure that any vehicle, kiosk or moveable stall used by him in connection with food business as hereinbefore defined has a Certificate of Compliance and that the facilities of the vehicle, kiosk or moveable stall are the same as existed when the Certificate of Compliance was granted.

11. The Licence holder must advise the Head of Legal & Property Services, The Inverclyde Council, Municipal Buildings, Greenock, in writing as soon as is reasonably practicable of any change in the information set out in the application form for this Licence.

Where the change in information is in respect of any vehicle, kiosk or moveable stall, used in connection with food business, no street trading will be carried out from any vehicle, kiosk or moveable stall unless or until a Certificate of Compliance has been issued in connection with such vehicle, kiosk or moveable stall.

Where the Licence holder intends to use a vehicle, kiosk or moveable stall other than that described in his application form and there is in existence a Certificate of Compliance in respect of such other vehicle, kiosk or moveable stall, such change will not require to be intimated to the Head of Legal & Property Services Services.
