This saving will mean that some families who live between 1 and 2 miles from a secondary school who are entitled to free school meals will no longer receive the monetary equivalent of a weekly bus pass. There will be an additional impact on pupils who attend St. Columba's High School Gourock because some pupils receive subsidised direct transport and this will now mean they may have to consider 2 buses.

Due to the implementation of the £20/week Child Poverty payment for any qualifying child between 6-16 years old from January 2023 and other Scottish Government funded initiatives to increase clothing grant payments and provide support for meals over school holidays, then the need for the Council to provide direct support over and above these supports is greatly reduced.
