Working people: The project will provide opportunities for employment through the delivery of the works and the construction of followon development of Inverkip Power Station. The contract for the works will be required to adhere to the Council's social value policy
which will provide benefits to the community which may include skills, training, and other community needs. The development itself will

also provide opportunities for work through the retail and commercial spaces created and for businesses to locate or grow in Inverclyde with the provision of modern facilities.

- Healthy people and places: The project will deliver infrastructure improvements on the A78 which will enhance walking, cycling and sustainable travel infrastructure and accessibility. The enabled development of the power station will enhance the natural environment by redeveloping a brownfield site which along with the other uses noted above will also include green spaces, play spaces and active travel routes through the site. The OBC is due to be presented to the GCR in November. Following this there will be development of the Full Business Case which will include a further review and where required revisions will be made.


When will the policy, function or strategy be reviewed?
