### **LICENSING BOARD FESTIVE SEASON POLICY 2024 – 2025**

There was submitted a report by the Depute Clerk of the Board on the proposed terms of the Festive Season Policy 2024 – 2025.

Ms Sinclair advised that the proposed Policy has been based on the Board's previous Festive Season Policies and that only events which relate to the festive season are applicable.

Sergeant Robertson confirmed that Police Scotland accept the same conditions as last year and in the event of any premises applying for later hours than those stipulated in the Policy, an objection would be submitted.

Councillor Brooks spoke about the possibility of Nightclub premises having later hours similar to a neighbouring licensing board area. There followed a discussion between Members on this subject.

Councillor Brooks moved grant of the Policy with an amendment to increase the nightclub terminal hour on 24 December, 25 December, 31 December 2024, and 1 January 2025 to 4.00am with bar to close at 3.30am.

As an amendment, Councillor McVey moved grant of the Policy as outlined in Appendix 2. On a vote, 2 Members (Councillors Brooks and Law) voted for the Motion and 5 Members (Councillrs Cassidy, McCormick, McVey, Reynolds and Robertson) voted for the amendment which was declared carried.

Ms Sinclair confirm grant of the Policy as follows:-.

#### Decided:

- (a) that 'blanket' extensions under section 67 of the Act for licensed premises (except Off Sales) shall be permitted;
- (b) that the Festive Season Policy will cover the period from Friday 6 December 2024 to Monday 1 January 2025 inclusive;
- (c) that licensed premises (except nightclubs) may open until 1.00 a.m. on Sunday to Wednesday and 2.00 a.m. Thursday to Saturday and nightclubs may open until 2.00 a.m. on Sunday to Wednesday and 3.30 a.m. (Bar to close 3.00 a.m.) on Thursday to Saturday;
- (d) that the terminal hour on Tuesday 24 December, Wednesday 25 December, Tuesday 31 December 2024 and Wednesday 1 January 2025 has the same terminal hour as Thursday to Saturday;
- (e) that the event being held must relate to the festive season e.g. Christmas Party Night, Hogmanay, and <u>not</u> to Birthday Parties, Weddings etc.;
- (f) that to assist the administration process, licence holders should notify the Police Scotland Licensing Department as soon as possible of those dates within the Festive Season Policy they intend to utilise; and
- (g) that occasional licence applications made for non-licensed premises e.g. Greenock Town Hall, Gamble Halls, Port Glasgow Town Hall, Community Halls etc for an event within the festive period may have the same hours granted in terms of the Festive Season Policy for events solely related to festive activities.

### POLICE SCOTLAND ANNUAL REPORT 2023 - 2024

Sergeant Robertson addressed the Board on the Police Scotland Annual Report highlighting points of interest to Members and concluded that it is a positive report for the Inverciyde Licensing Board.

Councillor Brooks thanked Sergeant Robertson for the work carried out and their support over the last year.

Members Noted the report.

### **GAMBLING ACT 2005: GAMBLING STATEMENT OF PRINCIPLES CONSULTATION**

Ms Sinclair advised that a consultation will be starting shortly in relation to review of the Board's Gambling Policy, summarised the process for such consultation, and advised that a report will be submitted to a future meeting of the Board on the outcome of the consultation. Ms Sinclair also advised that the policy requires to be reviewed every three years and that the review requires to be concluded by 13 April 2025, prior to expiry of the existing policy. A re

Mr Adiran Howlett, L-POS Ltd was present representing the application. Mr Antony Bonatti was in attendance.

Ms Sinclair advised that the required section 50 planning Certificate is in place. She intimated that a public objection had been received and read the contents of the objection to the Board. Ms Sinclair highlighted comments made by the Building Standards Officer confirming that the occupancy capacity figure should be 20 persons and the current layout plan will not enable food to be prepared or consumed on the premises.

Mr Howlett provided an updated layout plan showing that alterations had been carried out to the premises to permit food to be provided. A copy of the updated layout plan was circulated to Members.

Mr Howlett addressed the Board providing background information regarding his client and the proposed running of the business. He addressed the points raised by the objector and confirmed the occupancy capacity figure applied for should be amended to 20 persons as per Building Standards Regulations. Mr Howlett explained that it was anticipated the new layout plan would satisfy the Building Standards Officer that food can be provided, however he gave an undertaking to Members that if this proves not to be the case, the reference to food can be removed from the application at the point of Confirmation of the Provisional Licence, if granted.

Following discussion, Councillor Reynold moved grant of the application as amended with the undertaking which was unanimously agreed.
