Mr Stephen McGowan, Messrs TLT LLP was present representing the applicant. Mr David Carroll, licence holder was in attendance.

Ms Sinclair advised that the Health and Social Care Partnership had submitted a representation to the application and read the contents of their e-mail dated 17 April 2025 to the Board, a copy of which had been circulated to Members.

Sergeant Robertson and C Brown confirmed no comments to the application.

Mr McGowan addressed the Board outlining the project to incorporate the neighbouring property to form a function suite at the premises. He spoke to the comments raised by Health and Social Care Partnership and outlined Mr Carroll's experience in running licensed premises.

There followed a discussion between all parties. Mr Brown, Licensing Standards Officer confirmed he had visited the site and spoke with Mr Carroll on the development and operation of the proposals. Mr Carroll advised on Children and Young Persons being permitted and the installation of CCTV. Ms Sinclair intimated that as work is to be carried out at the premises, the occupancy capacity figure can not be confirmed by Building Standards until a building warrant completion certificate has been approved.

#### **Foreword**

It gives me great pleasure to provide the Annual Licensing Report for 2024/25, in accordance with Section 12(A) of the Licensing (Scotland) Act 2005.

Throughout the last year I have been committed to improving confidence amongst our communities by working in partnership with a focus on prevention, early intervention and proactivity. This supports our broader 2030 vision of safer communities, less crime, supported victims and a thriving work force.

In respect of Licensing, I recognise that success can only be achieved in collaboration with the 32 local authorities across Scotland. Along with contribution from many other associated national and local partners, this collaborative working ensures support for the licensed trade while also preventing alcohol fuelled violence, disorder and anti-social behaviour. Our joint campaigns which aim to protect children and young persons from harm will continue.

In the year ahead, our approach will remain focused on prevention and collaboration to ensure high standards of service delivery. I will continue to encourage officers and staff to engage with licensed premises and take relevant and proportionate action where appropriate to ensure licensing standards are maintained in the interest of the safety of the people of Scotland.

I would like to take this opportunity to once again thank our local partnerships for their contribution to maintaining high standards and driving improvement where necessary within the Licensed Trade for the benefit of the communities we all serve.

## Police Scotland Licensing Overview -

The Violence Prevention and Licensing Co-ordination Unit (VPLCU) sits within the National Policing Together Division and have staff based across the force. The department has overall responsibility for determining and delivering national licensing strategy and policy, providing advice, guidance and support to divisional licensing teams and undertaking other specialist functions.

The VPLCU is a specialist department which consists of a small team of officers. The officers within the unit work with divisional licensing teams and partner agencies to help shape policy and strategy around the police licensing function. They provide advice to police licensing practitioners, operational officers, supervisors and policing commanders.

The VPLCU seek to ensure that legislation governing the sale and supply of alcohol is applied consistently across the country and all opportunities are taken to stop the illegal or irresponsible sale, supply or consumption of alcohol with the intention of preventing and reducing crime and disorder.

During 2024/2025, from a licensing perspective, our particular focus was on the following;

- Scrutiny of the serious incidents of violence, disorder and antisocial behaviour linked to licensed premises.
- Delivering and promoting campaigns which seek to address issues arising from the consumption of alcohol, particularly in relation to young persons and in the context of the night-time economy.
- Governance and ongoing development of the National ICT Licensing System, known as "Inn Keeper", to increase the efficiency and effectiveness of liquor and civic licensing administration and management. Police Scotland continue to work on upgrading the National ICT system to ensure compliance with GDPR legislation.

Each of the 13 Local Policing Divisions have a licensing team responsible for the day to day management of licensing administration, complying with statutory requirements as well as addressing any issues that may arise within licensed premises in their local area.

#### LICENSING BOARD AREA

The Licensing Board area is policed by Renfrewshire and Inverclyde (K) Division

Chief Superintendent Rhona Fraser is the Local Police Commander who has the responsibility for all day-to-day policing functions.

## **Local Policing Priorities**

Following our public consultation process, the policing priorities for Renfrewshire and Inverclyde Division, as set out in our Local Policing Plan are as follows.

- Violence, Disorder and Anti-Social Behaviour
- Protecting Vulnerable People
- Acquisitive, Cyber and Digital Crime
- · Serious and Organised Crime
- Road Safety and Road Crime

The Licensing Board area is policed by Renfrewshire & Inverclyde Division.

Chief Superintendent Rhona Fraser is the Local Police Commander with responsibility for all policing functions.

Chief Inspector David Doherty is the Local Area Commander for Inverclyde with responsibility for the management of personnel, local service delivery, community engagement and partnership working to ensure local and national priorities are met for the reporting period.

Inverclyde is bordered to the north/west by the Firth of Clyde, the east by Renfrewshire and stretches south where it meets North Ayrshire. It has a population of over 80,000 people. It is one of the smallest in terms of area (29th) and population (27th) of the 32 Scottish unitary authorities.

The main population centres of Greenock, Port Glasgow and Gourock are surrounded by smaller local communities such as Wemyss Bay, Inverkip and Kilmacolm and policing delivery is tailored to meet the needs of those communities. Partnership working in Inverclyde is well established and those partnerships deliver a highly effective police service which has a positive impact on local communities.

Inverclyde has a rich and renowned history in shipbuilding and the 'deep water docking' on the Clyde offers berth to visiting cruise ships. Much investment has been made in education within Inverclyde with the area being home to the Greenock campus of West College Scotland.

There are currently 196 licensed premises in Inverclyde, 75 licensed off sales premises, 67 licensed premises for on sales only and 54 for both on and off sales.

## **OPERATION OF THE LICENSING (SCOTLAND) ACT 2005**

Alcohol misuse, exacerbated by its accessibility, availability and affordability, is commonly acknowledged as a contributory factor in incidents of violence, disorder and antisocial behaviour.

Police Scotland continues to work with its partner agencies, including the licensed trade, to reduce the impact alcohol misuse has on local communities. By working together, we can target those who fail or simply refuse to promote responsible trading practices. Together we can improve the safety and wellbeing of people, places and communities in Scotland.

Police Scotland currently have 3 levels for categorising licensed premises that come to our attention:

- Monitored Premises that require extra support and supervision. This can include premises coming to police attention through incidents or newly opened premises with inexperienced staff. A low-key approach is used to address issues before they escalate.
- Intervention A formal intervention agreement is put in place to improve the safe and legitimate operation of a premises. This intervention plan, which contains a list of conditions, is agreed between all parties. The intervention period would last a minimum of three months and be subject to review.
- Problematic Premises deemed problematic will normally be the subject of a premises licence review submission by Police Scotland to the Licensing Board.

Any categorised premises will be subject to regular inspections to ensure compliance and will form part of the tasking regime for the night-time economy action plans. All inspections, pro-active, re-active or planned are submitted via the Innkeeper system.

#### **Board Decisions**

Figures for the period 1<sup>st</sup> April 2024 to 31<sup>st</sup> March 2025 shows that there was one premise within Inverclyde which was monitored and subject to regular inspections. There were no premises in Inverclyde subject of a premises review during period.

## **Summary**

# PREVENTING THE SALE OR SUPPLY OF ALCOHOL TO CHILDREN OR YOUNG PEOPLE

## **Partnerships**

Partnership working is key to delivering tangible outcomes and we continue to strengthen our relationships with all agencies, community representatives and residents to ensure our services are co-ordinated, effective and efficient and address the needs of our communities.

## IT'LL COST YOU - Proxy Purchase Campaign

This Campaign focused on hot spot areas with educational interventions supported by third sector partners.

The main aims of the campaign were to

- Reduce the number of attempted purchases of alcohol for under 18s.
- Reduce crime and antisocial behaviour in the area.
- Reduce the vulnerability of those abusing alcohol under 18.
- Reduce the number of hospital admissions for under 18s with alcohol related injuries.
- Educate the public regarding the offence and dangers of proxy purchase within our communities.
- Educate Off-Sales and Licensed Premises to highlight the dangers of Proxy Purchase and operate within the Licensing Objectives.

The success of initiatives such as "Challenge 25" and joint work with Inverclyde Council have reduced the direct sale of alcohol to those under 18, however alcohol related violence and anti-social behaviour illustrate that younger age groups are increasingly gaining access to alcohol by other proxy sales. The most common method involves asking adults to buy alcohol for them.

The Licensing (Scotland) Act 2005 makes it an offence for a person to act as an agent for a child in purchasing or attempting to purchase alcohol'. This is known as proxy purchase. The penalties for this offence include a fine of up to £5000 and/or three months in prison.

Information from police was distributed to off licenses in Inverclyde and engagement undertaken with Licence holders.

Major supermarkets were approached, and joint social media posts were published with the major supermarket retailers. These premises also allowed campaign material to be left at alcohol aisles and front doors to their premises to publicise the campaign.

Morton football club and Inverclyde Council were supportive of the campaign.

#### NOT PROTECTIVELY MARKED

The campaign continued with joint initiatives with the preventions and interventions department carrying out engagement events at shopping centres within Inverclyde, local community Gala days and West of Scotland College campus through student services.

There has been a decrease across the division on youth related alcohol incidents which highlights the importance for the continuation of the campaign where certain areas have been highlighted for attention.

#### "No Knives Better Lives"

This is a national initiative and aims to raise awareness of the consequences of carrying knives and provides information on local activities and opportunities for young people. It is recognised that alcohol consumption influences risk taking behaviors.

'No Knives, Better Lives' training toolkit has been cascaded to secondary schools in Inverclyde

#### **Fearless**

This is the youth programme of Crimestoppers, it runs several campaigns over the year covering drugs and alcohol, child criminal exploitation, online harm, sextortion, summer safety and fire raising, all of which aim to educate young people on crime and encourage anonymous reporting to Fearless. Police Scotland supports their campaigns on our social media platforms and raise awareness within education settings and at public engagements.

## **Inverclyde Partnership Hub**

In 2021 the Inverclyde Partnership Hub was formed and implemented by Police Scotland to operate within Greenock Police Office. It was developed utilising good working practices adopted from elsewhere and tailored to operate in Inverclyde, building on strong partnership foundations already established. The aim of the Inverclyde Community Partnership Hub is to work with partners daily to tackle antisocial behaviour, violence, drug related deaths and identify vulnerability in Inverclyde by co-ordinating all partners in an efficient structured and cohesive manner.

The structure used ensures that the daily tasking and risk incidents are focused, relevant and with clearly identified areas of ownership.

Each meeting involves a review of Police, Fire, Community Warden or other significant incidents or events over the previous 24-hour period. Information is pro-actively disclosed to partners who attend the daily meetings where reasonable, appropriate, proportionate and lawful to do so for effective and early intervention. Key to the development of the Inverclyde Partnership Hub has been full engagement and

inclusion of key partners who have a responsibility for protection and wellbeing of our communities.

- Trading Standards / licensing enforcement from Local Authority
- Inverclyde Council Community Safety and Resilience

- HM Coastguard as and when required

#### TACKLING SERIOUS AND ORGANISED CRIME

The Serious Organised Crime Taskforce was set up to ensure Scotland can respond robustly to the threat posed by organised crime, identify improvements, and ensure all agencies are working to the same aims to raise public awareness. Membership of the group includes the Solicitor General; the Police Service of Scotland; the Prison Service; Her Majesty's Revenue and Customs (HMRC); National Crime Agency (NCA); Society of Local Authority Chief Executives (SOLACE); Her Majesty's Inspectorate of Constabulary Scotland (HMICS) and Scottish Business Resilience Centre (SBRC).

Its remit is to work together to help deliver the Scottish Government's commitment to tackling serious organised crime by:

- Identifying priorities for tackling serious organised crime (SOC) in Scotland.
- Sharing best practice and improving co-ordination between law enforcement agencies and others;
- Identifying innovative ways of working together and encouraging better ways of working together;
- Developing a coherent Scottish response on reserved and other SOC issues;
   and

Making proposals for legislation, research and other measures to tackle SOC.

There are several groups operating within the Inverclyde and Renfrewshire area, some of which have connections to the licensed trade, via licensed premises, second hand dealers, tanning salons and car wash facilities. Police Scotland, in conjunction with our partner agencies, have identified innovative ways to disrupt such organisations who are targeted through multi-agency days of action. Whilst it can be difficult to link these groups to serious crimes, targeting other crimes has proven to be a useful tool in disrupting their operations.

## PROPOSED ACTIVITY FOR THE YEAR AHEAD

## **Enforcement Operations**

The Licensing department will continue to plan and co-ordinate multi agency operations with officers from Home Office Immigration Enforcement (HOIE), His Majesty's Revenue and Customs (HMRC) and Inverclyde Council targeting all forms of licensed premises and persons within the area.
