- (iv) asked the Clerk to the Board to write to the Forum outlining their views on the report;
- (v) consider a meeting of the Board, Forum, Police, CHCP and other interested third parties to discuss the issues each have in relation to licensing; and
- (vi) an updated report on their findings be brought back to the Board for consideration.
