The Chair thanked the Police, Solicitors, Community Health & Care Partnership, Licensing Standard Officers, Depute Clerk, Administration staff and all Members of the Board for their assistance over the past 5 years.

LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR GRANT OF PREMISES LICENCE

Gillian Reith, applicant was present.

Mr Douglas advised the Board that all Section 50 Certificates have been granted.

The Board heard Ms Reith confirming children will be permitted on the premises as per the Board's Policy.

The Board agreed to grant the application.

LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR CONFIRMATION OF PROVISIONAL PREMISES LICENCE

Mr Tomlinson, Neill Clerk & Murray was present representing the applicant.

The Board heard Chief Inspector Shepherd removing the Police objection submitted as it was a duplication of their objection previously considered by the Board when determining the Provisional Premises Licence application.

Mr Douglas advised the Board of a discrepancy in the alcohol display area figure as depicted on the layout plan. The Board heard Mr Tomlinson confirming same and submitted amended plans with correct figure.

The Board agreed to grant the application.

LICENSING (SCOTLAND) ACT 2005 APPLICATION FOR PROVISIONAL PREMISES LICENCE

Arts & Drama Centre, (former Orangefield Baptist Church), Orangefield Place, Greenock

Mr Tomlinson, Neill Clerk & Murray was present representing the applicant together with Ms Varty, applicant. Mr Norman McNeil, objector was present.

The Board considered 7 public objections to the application. The Board heard Mr Tomlinson and Ms Varty in support of the application.

After discussion, Councillor McCallum moved grant of the application, as an amendment, Councillor Brooks moved refusal, on a vote, three members voted for the motion and three members for the amendment. The Chair had casting vote and declared the application granted within the Board's standard terms and conditions.

The Board considered 35 public objections, 5 public support letters and an observation by Community Health & Care Partnership.

The Board heard Ms Hunter in respect of the Community Health & Care Partnership observation, Mr Lamb in relation to his letter of support and Mr Clancy in support of the applicant.

The Board agreed to grant the application.

The Board agreed to grant the application.

Mr Douglas advised the Board that the Solicitor acting for the applicant has requested continuation of the application to the next meeting.

The Board agreed to continue the application to the next meeting of the Board.

LICENSING (SCOTLAND) ACT 2005 REQUEST TO VARY OCCASIONAL LICENCE CONDITIONS

Anthony Buckley, Inverciyde Catering & Events Ltd, 31 Turnberry Avenue, Gourock

Mr Ian Scott, President, Port Glasgow Boys Club was present representing the licence holder.

Mr Douglas advised the Board that Mr Scott sought a variation to the Occasional Licence previously granted to Mr Buckley. The licence was in respect of a Presentation evening for Port Glasgow Boys Club. The variation sought was in respect of the terminal hour of 11.00 p.m. when children have to leave the premises.

The Board heard Mr Scott in support of his request. The Board heard Chief Inspector Shepherd and Ms Hunter objecting to the request.

The Board agreed to grant the request and allow children to attend the event to the terminal licence hour of 12.45 a.m.

LICENSING (SCOTLAND) ACT 2005 REVIEW OF PREMISES LICENCE

Unity Club, Southfield Avenue, Port Glasgow

Mr O'Donnell, Blair & Bryden was present representing the licence holder together with Mr Morrison and Mr Patrick, Committee Members of the Club.

Mr Douglas advised the Board that Strathclyde Police and Licensing Standards Officer requested review of the Premises Licence at Unity Club, Southfield Avenue, Port Glasgow.

The Board agreed that grounds for review were met.

The Board heard Chief Inspector Shepherd and Mr Cushnaghan in support of their request. The Board heard Mr O'Donnell, Mr Morrison and Mr Patrick in support of the licence holder.

After discussion, the Board unanimously agreed to suspend the Premises Licence for a period of three weeks with immediate effect to allow:-

- (i) new Committee to be formed;
- (ii) to seek assistance from Police, Licensing Standards Officer, Solicitor, Training Providers etc to assist in adhering to legislation;
- (iii) all bar staff to undergo training and records to be created and kept;
- (iv) Police and Licensing Standards Officer to visit the premises prior to re-opening to ensure all Notices are displayed appropriately; and

(v) An impromptu visit will be undertaken after the 3 week period of suspension by the Licensing Standards Officer and if any further reports are brought back to the Board's attention a more stringent outcome may be imposed to ensure the licensing objectives and legislation are being adhered to.

LICENSING (SCOTLAND) ACT 2005 THE QUEEN'S GOLDEN JUBILEE EXTENDED HOURS

The Board considered a report by the Clerk to the Board to determine whether the Board wishes to extend the terminal hour of Premises Licences on the day of the Queen's Jubilee or any day/s preceding it and whether or not the curfew should cease operation during the said period(s).

The Board heard Chief Inspector Shepherd objecting to a blanket extension of hours and any change to the curfew. Their preference being licence holders apply for individual extended hours applications.

After discussion the Board agreed:-

- (i) all premises licences (except off sales) be granted a 1 hour extension to their existing terminal core hour for the evenings of Saturday 2 June, Sunday 3 June, Monday 4 June and Tuesday 5 June 2012; and
- (ii) no change to the current curfew.
