1.0 PURPOSE

1.1 The purpose of this report is to provide the Alliance Board with an outline of progress against the outcomes and indicators set out in the Outcome Delivery Plans for the Single Outcome Agreement 2013 -17.

2.0 SUMMARY

- 2.1 Each Outcome Delivery Group has an Outcome Delivery Plan. Quarterly reports are presented to each meeting of the Programme Board and Alliance Board on the progress made in delivering the actions set out in the plan. As a number of new Outcome Delivery Plans are currently in the process of being finalised, this report focuses on the performance of the following Outcome Delivery Groups in the previous quarter:
 - Employability / Economic Regeneration (SOA3)
 - Alcohol Misuse (SOA5)
 - Best Start in Life for Children and Young People (SOA6)

Performance highlights are set out in paragraph 4.8 whilst appendix one contains a summary of progress across all improvement actions, presented according to the relevant wellbeing outcome.

- 2.2 There is one amber action in this quarter and one red action:
 - **Amber** Increase the level of residents with core skill qualifications for employment. The annual target for this is 72. In the first quarter of 2015/15, 3 candidates completed the core skill qualification. The target of 72 is a year-end target and it is too early in the year to meet this due to the time taken to complete qualifications. It is expected that further into the year, performance will be on track. The feasibility of quarterly targets will be considered to provide a more accurate picture of performance.
 - Red An online Children's Services plan, which focuses on 'Nurturing Invercive' is available on the Council's website and is delivered through the wellbeing outcomes across partners. This action was initially scheduled to be complete by November 2014. The slippage is primarily due to ICT difficulties however these have now been resolved. The Council has partnered West College Scotland to commission students to implement a "user friendly" interactive website and / or mobile app aimed at young people who require information and advice in a more targeted format. All current advice, plans and policy documents will be published to <u>www.inverclyde.gov.uk</u> to provide a formal point of reference for the Council's approach. The anticipated completion date is the end of November / early December 2015.

- 2.3 The following table summarises overall performance for each of the actions against the wellbeing outcomes against the BRAG status.
 - <u>Blue</u> means that the action is complete.
 - <u>Red</u> means that performance is not expected to meet target and that immediate action is required if not already taken.
 - <u>Amber</u> indicates that performance is not in line with what was expected when targets were set and requires close monitoring. If the situation does not improve, corrective action will be required.
 - <u>Green</u> indicates that performance is on track on target.
- 2.4 The Alliance Board is aware that the Repopulation, Successful Communities and Environment Outcome Delivery Groups have all agreed to refresh their outcome delivery plans. This is to ensure that the recent discussions around inequalities, partnership working and added value are embedded in the plans. This has resulted in each group identifying a smaller, more challenging number of improvement actions that will be taken forward through partnership working. Due to the more stretching nature of the new outcome delivery plans, future quarterly performance reports may report more slippage (amber and red actions) than at present. Work is currently ongoing to finalise the improvement actions to be included in all three outcome delivery plans.
- 2.5 Partnership working between Health Scotland and the Health Inequalities group is continuing and a report providing a full update on this is on the agenda of this meeting.
- 2.6 The SOA Programme Board has discussed the issue of inequalities at length and agreed that as tackling this issue is a priority across the Partnership, all reports to the Alliance must set out how the actions or recommendations will help to tackle inequalities. A new heading 'Inequalities' will be added to the 'Implications' section of all reports to facilitate this.
- 2.7 Currently, the position of lead officer / chair of the Economic Regeneration and Employability group and the Best Start in Life group is vacant. Interim chairs are in place and DWP will be approached to nominate an officer to continue as chair of the Economic Regeneration & Employability group. Once in post, Wilma Bain, the new Corporate Director Education, Communities & Organisational Development will take over the position of Chair of the Best Start in Life Group.

4.0 BACKGROUND

4.1 Each local outcome in the SOA has a lead officer who is responsible for the delivery of the outcome. The lead officer is supported by an Outcome Delivery Group consisting of partner organisations that have a role to play in the achievement of the outcome and an Outcome Delivery Plan that sets out the actions that will be taken to help achieve the outcome.

- 4.3 The SOA Outcome Delivery Groups are working to deliver the outcomes set out in the SOA. It is the responsibility of the lead officers to drive the outcomes by providing clear leadership and direction. Lead officers are responsible for leading outcome delivery groups and for facilitating and co-ordinating the development of outcome delivery plans and reporting on these. New lead officers will shortly be in place for the Economic Regeneration / Employability and Best Start in Life Outcome Delivery Groups.
- 4.4. The Repopulation, Successful Communities and Environment Outcome Delivery Groups have all met over the summer months to discuss priorities and the areas for improvement that will form the basis of their new Outcome Delivery Plans.
 - The Environment Group met on 19 June 2015. The group agreed to significantly revise the existing outcome delivery plan. New areas of partnership working that will be explored include Community Food Growing (as required by the Community Empowerment (Scotland) Act); Green Network and an Environmental Network / Forum;
 - The Repopulation Outcome Delivery Group participated in a half day workshop on 24 June to discuss the priorities for the group and new improvement actions. The focus of the meeting was a presentation by John McCreadie from Ekosgen on what makes regeneration successful, including the private rented sector, employment growth, housing and place and promoting a positive message every time;
 - The Successful Communities group also met on 7 August. The group discussion focused on collaborative partnership working at operational and practical levels and sharing information. New areas of partnership working that are being considered include a focus on the safety of older people and anti-social behaviour.
- 4.5 In developing the new Plans the focus has been on addressing inequalities, stronger partnership

working and added value to community planning. This has resulted in each group identifying a smaller, more challenging number of improvement actions that will be taken forward. Due to the more stretching nature of the new outcome delivery plans, future quarterly performance reports may report more slippage (amber and red actions) than at present. The Outcome Delivery Plans for all three groups are currently being finalised.

- 4.6 The partnership between the Health Inequalities group and Health Scotland is ongoing and a report on progress is also on the agenda of this meeting.
- 4.7 The SOA Programme Board has discussed the issue of inequalities at length and agreed that as tackling this issue is a priority across the Partnership, all reports to the Alliance must set out how the actions or recommendations will help to tackle inequalities. A new heading 'Inequalities' will be added to the Implications section of all reports to facilitate this.
- 4.8 Highlights of progress made across the SOA Outcomes are set out below.

Economic Regeneration / Employability

Riverside Inverclyde and Inverclyde Council are actively pursuing securing the first ever Powerboat P1 Scottish Grand Prix of the Sea for Greenock for June 2016.

A Regeneration Capital Grant Fund award was confirmed for Riverside Inverclyde of almost £650k which will allow the final phase of the Custom House refurbishment to begin during the current financial year.

Inverclyde Council have completed tendering for the delivery of City Deal employability programme which will support 200 individuals on Employment Support Allowance.

The published School Leaver Destination Results show Inverciyde's favourable performance against Scotland as a whole. 94% of Inverciyde's 796 School Leavers entered a Positive Destination. It is also the 5th year running where Inverciyde have had no young people unknown to partners.

The Inverclyde Employability Fund Local Employability Partnership continues to meet to review performance of the Employability Fund providers in the area. There were 335 places awarded in 2015/16.

Partners delivered a Jobs Fayre on 11th August in Greenock Town Hall with approximately 800 clients attending the event.

The claimant count continues to improve; there are currently 1,697 individuals on JSA – a rate of 3.3%. In July 2014, the figure was 1907 at a rate of 3.7%. However, the significant issue within the Inverclyde labour market remains insufficient jobs, with a lower jobs density than the Scottish average.

Alcohol Misuse

As a result of the #Clyde Conversations conference, a pilot project is underway to develop peer education in one high school where senior pupils will support alcohol education to younger pupils. Peer Education Training [IIAS] will begin in August with a group of S6 pupils in Port Glasgow High School.

A new recovery initiative, Culture Change, which is a clean and sober social evening, is now in place in Crown Care on the last Friday of the month. Approximately 50 people are attending on a regular basis. Access to a crèche is also available.

There has been intensive training and liaison input to Acute regarding Alcohol Brief Interventions. There has been a reduction in offending of 22.3% for active clients of the Persistent Offenders Partnership (POP).

Best Start in Life for Children and Young People

Inverclyde Council's Rights Respecting Residential Award was highly commended in the Scottish Institute for Residential Child Care (SIRCC) awards (Reaching Higher Award). The majority of looked after children achieved significantly more than one qualification in 2014/15; most pupils completed S4 with at least four qualifications at SCQF Level 3, 4 or 5.

A young person with care experience has been appointed through the HSCP to help gather the voices of young people to influence the development of the Youth Participation Strategy. Messages from the Clyde Conversations Conference have also been taken on board. A proposal from Inverclyde's Young People's Champion to develop a 'Youth Senate' is being explored as an additional mechanism to ensure young people have their voices heard.

A recall event with the young people involved in organising #Clyde Conversations was held on 23 June 2015.

5.0 Performance

Performance overall this quarter remains good. There is one amber action and one red action:

• Increase the level of residents with core skill qualifications for employment (Amber).

The annual target for this is 72. In the first quarter of 2015/15, 3 candidates have completed the core skill qualification. The target of 72 is a year-end target and it is too early in the year to meet this due to the time taken to complete qualifications. It is expected that further into the year, performance will be on track. The feasibility of quarterly targets will be considered to provide a more accurate picture of performance.

• An online Children's Services plan, which focuses on 'Nurturing Inverclyde', is available on the Council's website and is delivered through the wellbeing outcomes across partners. This action was initially scheduled to be complete by November 2014. (Red)

The slippage is primarily due to ICT difficulties however these have now been resolved. The Council has partnered West College Scotland to commission students to implement a "user friendly" interactive website and / or mobile app aimed at young people who require information and advice in a more targeted format. All current advice, plans and policy documents will be published to <u>www.inverclyde.gov.uk</u> to provide a formal point of reference for the Council's approach. The anticipated completion date is the end of November / early December 2015.
