1.0 PURPOSE

The purpose of this Report is to:

2.0 SUMMARY

It is a Mandatory Condition of the Premises Licence that an annual fee must be paid as per the Licensing (Fees) (Scotland) Regulations 2007. The amount payable is determined by the rateable value of the premises, in the case of Club Premises Category 1 applies.
