1.0 PURPOSE

1.1 The purpose of this report is to request the Board to consider whether Extended Hours of Premises Licences should be granted during significant events being held in 2014, and to determine the procedure for granting such extensions. These events are:-

- FIFA World Cup 2014 (12 June – 13 July)
- Glasgow Commonwealth Games 2014 (23 July – 3 August)
- The Scottish Referendum Vote (18 September)
- The Ryder Cup (26 – 28 September)

2.0 SUMMARY

2.1 The Licensing Section has received enquiries as to the Board's intentions for Extended Hours for significant events to be held in 2014.

2.2 The Board has in the past decided that certain special events should be granted extended hours for the sale of alcohol. The decision to grant such extended hours has been considered on the merits of each individual event. The Board are therefore asked to consider the upcoming events of 2014 and determine whether, in their view, the events are of a local or national significance that would warrant a deviation from its licensing policy and for extended hours to be granted.

2.3 In the event that the Board decides that any or all of the following events should result in extended opening hours, they must decide if the extension is granted under Section 67 or Section 68 of the Licensing (Scotland) Act 2005.

- FIFA World Cup 2014 (12 June – 13 July)
- Glasgow Commonwealth Games 2014 (23 July – 3 August)
- The Scottish Referendum Vote (18 September)
- The Ryder Cup (26 – 28 September)

2.4 Under Section 67 of the 2005 Act, a Board may, if they consider it appropriate to do so in connection with a special event of local or national significance, make a determination extending licensed hours by such period as the Board may specify in the determination. Such extensions cannot be granted to off-sales premises operating with a terminal hour of 10:00pm

2.5 Under Section 68 of the 2005 Act, a Board may extend the hours in respect of a particular premises on the application by the premises licence holder if it considers it appropriate to do so in connection with a special event of local or national significance.

2.6 Police Scotland have been advised on the content of this report and have intimated that they will provide oral submissions to the Board.

3.0 RECOMMENDATIONS

- 3.1 It is recommended that the Board consider each event in turn and determines if Extended Hours are warranted in respect of the particular event in question.
- 3.2 If Extended Hours are to be granted in respect of all or any of the events, the Board are asked to consider if such extensions are to be granted under Section 67 or 68 of the Act.
- 3.3 If Section 67 is to apply, the Board will require to determine the dates and times to be allocated.
- 3.4 If Section 68 is to apply, the Board will require to determine acceptable terminal hours for Monday – Sunday where appropriate.
