## 1.0 PURPOSE

1.1 The purpose of this Report is to:

- (i) Provide Members with the current position as to arrears of 2014 – 2015 Premises Licence Annual Fee Payments which were due to be paid on or before 1 October 2014; and
- (ii) Request the Board to consider Review of Premises Licences for those premises where annual fee payment has not been paid in full.

## 2.0 SUMMARY

2.1 It is a Mandatory Condition of the Premises Licence that an annual fee must be paid as per the Licensing (Fees) (Scotland) Regulations 2007. The amount payable is determined by the rateable value of the premises, in the case of Club Premises Category 1 applies.

2.2 The following table shows the amount of outstanding annual fees at the time of preparing this report:-
