1.0 PURPOSE

- 1.1 The purpose of the report is to seek approval of the Board that those matters which may be delegated to the Clerk of the Board are duly delegated.

2.0 BACKGROUND

- 2.1 The Licensing (Scotland) Act 2005 allows Licensing Boards to authorise the Clerk of the Board to exercise on behalf of the Board any of the Board's functions under the Act apart from functions outlined below at paragraph 2.2. The functions outlined at paragraph 2.2 must remain the sole preserve of the Board and may not be delegated.

- 2.2 Those functions which remain the sole preserve of the Board are:

- (a) determining the Board's Policy for the purposes of a Licensing Policy Statement or Supplementary Licensing Policy Statement;
- (b) determining for the purposes of any such statement, whether there is overprovision of licensed premises or licensed premises of any particular description in any locality;
- (c) determining a premises licence application;
- (d) determining a premises licence variation application where the variation sought is not a minor variation;
- (e) determining an application for the transfer of a premises licence where the applicant has been convicted of a relevant offence or a foreign offence;
- (f) determining a personal licence application or a personal licence renewal application where the applicant has been convicted of a relevant offence or a foreign offence and opposition to the application to the grant or renewal has been lodged by any statutory consultee;
- (g) conducting a hearing under the Licensing (Scotland) Act 2005 (including taking any steps thereafter as a result of the hearing);
- (h) making an order revoking, suspending or endorsing a personal licence.
- (i) the granting of an occasional licence application where there is a notice of objection or representation in relation to the application, or a notice from the appropriate Chief Constable recommending refusal of the application

3.0 RECOMMENDATION

- 3.1 That the Board grants delegated authority to the Clerk of the Board to exercise on behalf of the Board any of the Board's functions specifically not excluded as per paragraph 2.2.
