Subject:	LOIP Governance and Delivery Structure		

1.0 PURPOSE

- 1.1 The purpose of this report is to set out a revised governance and reporting structure for the delivery of community planning and the Local Outcome Improvement Plan (LOIP).

2.0 SUMMARY

- 2.1 There have been a number of changes to the structures for delivering Community Planning with the end of the Single Outcome Agreement and the introduction of the LOIP and Locality Plans. It has therefore been necessary to develop a new governance structure to reflect these changes and facilitate the delivery of the LOIP and Locality Plans.
- 2.2 A draft governance and delivery structure was considered by the Alliance Board at its last meeting on the 11th of December 2017. The Alliance Board asked for further work to be carried out to make it clear what has happened to the previous SOA Outcome Delivery Groups.
- 2.3 The LOIP Programme Board discussed the proposed governance and delivery structure at its last meeting on the 9th of February 2018. The Programme Board also asked for a number of amendments to be made and the governance and delivery structure has been updated to reflect both the comments of the Alliance Board and LOIP Programme Board.
- 2.4 Appendix one contains a proposed structure for the delivery of the LOIP and the three locality plans for Port Glasgow, Greenock East and Central and Greenock South and South West. The partnerships in this structure will report to the Programme Board and Alliance Board on a quarterly basis.
- 2.5 Appendix 2 contains a proposed structure for community planning across Inverclyde. There are groups/partnerships which do not specifically target the LOIP priorities but are part of the Alliance's community planning structure. Legislation dictates that Community Justice Partnerships, CLD and Joint Children's Services Planning should all sit within community planning. Appendix two contains a proposed structure for these groups. These groups will report directly to the Alliance Board on an annual basis.

3.0 RECOMMENDATIONS

It is recommended that the Alliance Board:

- a. Reviews and agrees the governance and delivery arrangements for community planning and the delivery of the LOIP.

4.0 BACKGROUND

- 4.1 As part of the review of the Single Outcome Agreement and the development of the Inverclyde Outcomes Improvement Plan the structure for the delivery of the Community Planning Partnership has changed. Following feedback from partners it was also agreed to try to reduce the number of groups dealing with Community Planning outcomes and priorities.
- 4.2 A draft governance and delivery structure was considered by the Alliance Board at its last meeting on the 11th of December 2017. The Alliance Board asked for further work to be carried out to make it clear what has happened to the previous SOA Outcome Delivery Groups.
- 4.3 The LOIP Programme Board discussed the proposed governance and delivery structure at its last meeting on the 9th of February 2018. The Programme Board also asked for a number of amendments to be made and the governance and delivery structure has been updated to reflect both the comments of the Alliance Board and LOIP Programme Board.
- 4.4 Appendix one contains a proposed structure for the delivery of the LOIP and the three locality plans for Port Glasgow, Greenock East and Central and Greenock South and South West. The partnerships in this structure will report to the Programme Board and Alliance Board on a quarterly basis.
- 4.5 The LOIP priorities are Repopulation, Reducing Inequalities and Environment, Culture and Heritage. The Repopulation Outcome Delivery Group will continue as the Repopulation Partnership, the Environment Outcome Delivery Group will continue as the Environment Partnership and the new Cultural Partnership will cover the Culture and Heritage part of the priority. The chairs of the Environment Partnership and the Cultural Partnership will meet regularly to pull together updates for the Programme and Alliance Boards.
- 4.6 Following feedback from the Alliance Board and LOIP Programme Board, the following changes have been made to Appendix one:
- The Inverclyde Regeneration and Employability Partnership, which was previously an SOA Outcome Delivery Group, will now report into the Repopulation Partnership.
 - The Inverclyde Alcohol and Drug Partnership, which was previously an SOA Outcome Delivery Group, will now report into the three Locality Planning Partnerships.
- 4.7 Appendix 2 contains a proposed structure for community planning across Inverclyde. There are groups/partnerships which do not specifically target the LOIP priorities but are part of the Alliance's community planning structure. Legislation dictates that Community Justice Partnerships, CLD and Joint Children's Services Planning should all sit within community planning. Appendix two contains a proposed structure for these groups. These groups will report directly to the Alliance Board on an annual basis.
- 4.8 Following feedback from the Alliance Board and LOIP Programme Board, the following changes have been made to Appendix 2:
- The Inverclyde Regeneration and Employability Group and Inverclyde Alcohol and Drug Partnership have been moved from Appendix 2 to Appendix 1.
 - The Health and Social Care Partnership has been removed from Appendix 2.
 - Joint Older People's Services Partnership has been removed from Appendix 2.
 - The previous SOA Outcome Delivery Groups have been highlighted. These are the Community Safety Strategic Partnership, which was previously SOA 2 and the Joint Children's Services Partnership, which was previously SOA 6.

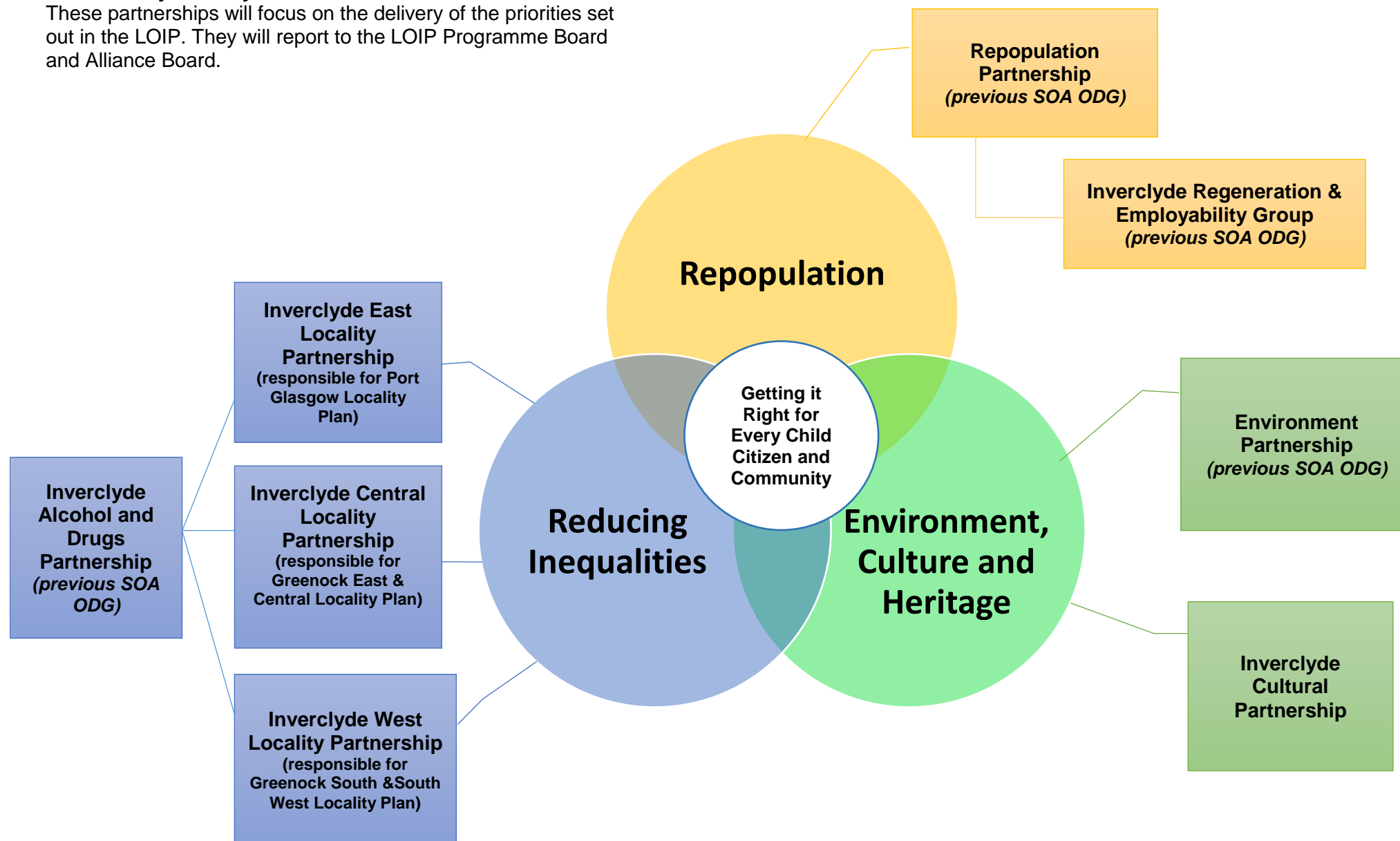
