### MINUTE OF PREVIOUS MEETING

The minute of the meeting of 6 October 2014 was submitted and approved.

### **MATTERS ARISING**

### **Inverciyde Alliance Young People's Conference**

There was submitted a note providing information on the proposed Inverclyde Alliance Young People's Conference scheduled for 11 March 2015.

It was noted that it may be necessary for the date to be changed due to another event on the same day and Councillor McCabe stressed the importance of confirming the new date as soon as possible.

### SINGLE OUTCOME AGREEMENT 2013-17: QUARTERLY OUTCOME DELIVERY GROUPS PROGRESS REPORTS

There was submitted a report by the Chair of the SOA Programme Board providing an outline of progress against the outcomes and indicators set out in the Outcome Delivery Plans for the Single Outcome Agreement 2013-17.

### Decided:

- (1) that the Board note the progress made across the various Outcome Delivery Groups;
- (2) that it be noted that future progress reports will include updates from the Alcohol Misuse and Best Start in Life Outcome Delivery Groups; and
- (3) that it be noted that a new Health Inequalities Outcome Delivery Plan will be submitted to a future meeting of the Board.

### INVERCLYDE ALLIANCE IMPROVEMENT PLAN

There was submitted a report by the Chair of the SOA Programme Board on the Inverciyde Alliance Improvement Plan which incorporates the feedback from the recent Alliance Board Workshop.

The Board also heard a presentation on this item by Ms McKenna, a copy of which is attached as Appendix 1.

There was discussion on the improvement actions identified, with particular reference to Asset Based Approaches and the need for proper awareness as to what this means in practice. In connection with the Tackling Inequalities improvement action, Councillor McCabe expressed the view that it would be extremely useful for the Board to go out into the communities, particularly to some of the most deprived neighbourhoods and he suggested that this could be done at the March meeting in place of the workshop session.

### Decided:

- (1) that the Inverclyde Alliance Improvement Plan be approved;
- (2) that the Improvement Plan be a standing item on the SOA Programme Board agenda;
- (3) that a progress report on the Improvement Plan be submitted to each meeting of the Alliance Board;
- (4) that a visit to local communities be incorporated into the arrangements for the meeting of the Board on 23 March 2015; and
- (5) that a workshop session on Asset Based Approaches be arranged for Board Members.

### **REVISED SOA OUTCOME DELIVERY PLANS**

There was submitted a report by the Chair of the SOA Programme Board presenting for approval the new Outcome Delivery Plans for (a) SOA3 (Economic Regeneration and Employability), (b) SOA5 (Alcohol Misuse) and (c) SOA6 (Best Start in Life for Children and Young People).

The Board heard presentations by Mr Fleming on SOA3, Mr Moore on SOA5 and Ms Cassidy on SOA6 (Appendices 2, 3 and 4 to the minute).

(Councillor MacLeod left the meeting during consideration of this item of business).

During the course of the presentation on SOA3, there was discussion on the difficulties faced by groups and individuals, such as those with health problems or a disability in gaining access to employment opportunities and reference was made by Mr Fleming to the use of the flexible support fund to help remove barriers to employment. There was also discussion on the need to provide training in areas where there are shortages of workers such as drivers.

Arising from this it was suggested that work should be carried out by the SOA3 Outcome Delivery Group to identify areas where training could be provided with a view to preparing applicants to fill jobs where significant demand exists.

Reference was made during the presentation on SOA5 to the need for evidence to support the delivery plan and Councillor McCabe requested that a statistical report be prepared for submission to the Board. He also referred to the ongoing budget consultation process where important decisions would be taken informed by the priorities of the Alliance Board. He suggested that a session be arranged for Board Members before the 17 January budget consultation deadline to examine the challenges faced by the Alliance and this was agreed.

### Decided:

- (1) that approval be given to the new SOA3, SOA5 and SOA6 Outcome Delivery Plans and to the proposed actions arising from the discussion on these, as set out above:
- (2) that it be noted that a quarterly progress report for each of these plans will be submitted to future meetings of the Alliance Board; and
- (3) that it be noted that the revised SOA4 Health Inequalities Outcome Delivery Plan will be submitted to a future meeting of the Alliance Board.

### ORKNEY COMMUNITY PLANNING PARTNERSHIP BEST VALUE REPORT

There was submitted a report by the Corporate Director Education, Communities & Organisational Development, Inverclyde Council providing an overview of the Audit Scotland Best Value Audit of Orkney Community Planning Partnership.

### Decided:

- (1) that the key messages from the Best Value Audit Report for Orkney Community Planning Partnership be noted;
- (2) that it be remitted to the Programme Board to examine the activity required to prepare Inverciyde Alliance for any future Best Value Audit and that this be reported to the Alliance Board;
- (3) that it be agreed that the SOA Programme Board provide feedback to the Outcome Delivery Groups regarding issues raised by Best Value Community Planning Partnership audits;
- (4) that it be remitted to the Successful Communities Outcome Delivery Group to learn from the Orkney Community Planning Partnership good practice in regard to community engagement; and
- (5) that it be remitted to the Third Sector Interface to learn from Orkney's good practice in regard to involvement in support of the third sector.

### "DELIVERING DIFFERENTLY" PARTNERSHIP CONSULTATION WORKSHOP

There was submitted a report by Brian Fleming, JobcentrePlus seeking approval for a partnership consultation workshop "Delivering Differently" which would focus on current delivery achievements, future known changes, current issues and ideas for resolution under the banner "DWP Delivering Differently".

### Decided:

- (1) that the Alliance Board endorse the workshop as proposed and promote attendance to invitees; and
- (2) that the Board review public services locally using the feedback from the workshop.

### **EFFECTIVE DEMOCRACY: RECONNECTING WITH COMMUNITIES**

There was submitted a report by the Corporate Director Education, Communities & Organisational Development, Inverclyde Council/Lead Officer Best Start in Life ODG on the Commission on Strengthening Local Democracy report "Effective Democracy: Reconnecting with Communities".

### Decided:

- (1) that the content of the Commission on Strengthening Local Democracy report "Effective Democracy: Reconnecting with Communities" be noted; and
- (2) that the report be remitted to SOA2 (Successful Communities) with a view to its forming the Community Engagement Strategy.

### **UPDATE - FERGUSONS TASK FORCE**

There was submitted a report by the Corporate Director Environment, Regeneration & Resources, Inverclyde Council providing an update on progress at Fergusons Shipyard and the implementation of the recommendations agreed by the task force put together during the recent closure and subsequent purchase by new owners.

### Decided:

(1) that the Board note the progress made with Fergusons and the recommendations of the task force;

- (2) that it be remitted to the SOA3 Outcome Delivery Group to progress any potential opportunities for employment in the engineering sector; and
- (3) that it be noted that further dialogue is planned between the Scottish Government and Inverclyde Council regarding funding for the regeneration of Port Glasgow Town Centre and that the issue of funding for the project continue to be pursued.




