Subject: Process for Tackling Poverty and Multiple Deprivation in Inverclyde

1.0 PURPOSE

1.1 The purpose of this report is to provide Policy and Resources Committee with details of the process to reinvest £750,000 funding from Inverclyde Council, supplemented by £250,000 from the Integration Joint Board (IJB), to create a £1million investment in our communities. This funding will be used to mitigate poverty, reduce inequalities and deprivation, with a particular focus on engaging and empowering those living in the localities that fall within the most deprived in Scotland, according to the SIMD 2020.

2.0 SUMMARY

- 2.1 The Scottish Government published the Scottish Index of Multiple Deprivation on 28 January 2020. The SIMD is a Scottish Government tool for identifying places in Scotland suffering from deprivation.
- 2.2 Prior to the SIMD 2020 being published, the Inverclyde Alliance had already identified three of Inverclyde's six localities (Port Glasgow, Greenock East and Central, Greenock South and South West) as having the greatest level of poverty and deprivation in Inverclyde. These localities remain in the 20% most deprived in Scotland. Locality planning and communication and engagement groups are currently being established in all 6 localities and residents are being encouraged to participate in agreeing the priorities and plans for their community.
- 2.3 The £1million funding will be targeted towards specific actions, initiatives and programmes within Inverclyde's most deprived localities. This will be based on the evidence of need and what will have the greatest impact. The funding will also be used to provide support for people living in low income households or poverty across the community of Inverclyde.
- 2.4 The £1million will be allocated across two broad areas of activity. Firstly, £400,000 funding will be made available to implement initiatives on an Inverclyde wide basis. These initiatives will be developed by officers and a report will be presented to the Policy and Resources Committee in May 2020.
- 2.5 Secondly, the 3 most deprived localities will each receive a percentage of £600,000 depending on the levels of multiple deprivation within that locality. It is proposed that the funding be split:

50% - Greenock East & Central

25% - Port Glasgow

25% - Greenock South & South West

This funding will be targeted towards initiatives to address unemployment and employability, support for people experiencing difficulties with alcohol and drugs and people who are classed as homelessness or people who are experiencing food insecurities. A schematic of the timescale and processes in relation to the re-invested anti-poverty and multiple deprivation funding is provided in Appendix 1.

- 2.6 Inverclyde Council recently approved a revised approach to mainstream participatory budgeting in Inverclyde. The revised model focuses on the prioritisation of budgets/services by engaging and empowering people living within Inverclyde's localities to be involved in decision making at a level where it will have the biggest impact.
- 2.7 The proposed process to tackle poverty and multiple deprivation will build on participatory budgeting and will:
 - Provide the Locality Planning and the associated Communication and Engagement Groups, alongside other existing community groups with presentations and information from officers on the key challenges that exist within their locality.
 - A range of suggested interventions will be developed and residents will be encouraged to debate how this funding should be prioritised to make the biggest difference to the locality.
 - Members of the groups will be encouraged to participate in the democratic decision making process using voting electronic platforms such as Citizen Space on what interventions they would like in their communities.
 - Once the initiatives have been agreed, the Locality Planning Groups and the Communication and Engagement groups will continue to be engaged on the development and implementation of initiatives within their community.

The proposed timetable for the delivery of the above can be found in paragraph 5.5.

- 2.8 The Scottish Government has requested that all 32 local authority areas in Scotland submit proposals on how they will take forward the Local Governance Review. This proposed process in Appendix 1 is aligned with the Scottish Government's commitment to subsidiarity and aims to deliver community empowerment, functional empowerment and fiscal empowerment for the people living within the localities of Invercive.
- 2.9 The Policy and Resources Committee will receive regular updates on the progress of the proposals for tackling poverty and multiple deprivation in Inverclyde as part of the locality planning progress reports.

3.0 RECOMMENDATIONS

- 3.1 It is recommended that the Policy and Resources Committee:
 - a. Approves the proposed process in relation to the re-invested anti-poverty and multiple deprivation funding as set out in Appendix 1.
 - b. Agrees to receive regular progress updates.
 - c. Agrees that this process can be submitted to the Scottish Government by 27 March as Inverclyde's proposal for the Local Governance Review.

4.0 BACKGROUND

- 4.1 The Scottish Government published the Scottish Index of Multiple Deprivation on 28 January 2020. The SIMD is a Scottish Government tool for identifying places in Scotland suffering from deprivation. It uses data relating to multiple aspects of life (income, employment, health, education, access, crime and housing) in order to gain the fullest possible picture of deprivation across Scotland.
- 4.2 Prior to the SIMD 2020 being published, the Inverclyde Alliance had already identified three localities (Port Glasgow, Greenock East and Central, Greenock South and South West) as having the greatest level of poverty and deprivation in Inverclyde, these localities remain in the 20% most deprived in Scotland. Locality planning and communication and engagement groups are currently being established in 6 localities areas in Inverclyde and people are being encouraged to participate in agreeing priorities and plans for their community.
- 4.3 Inverclyde Council recently approved a revised approach towards mainstreaming participatory budgeting in Inverclyde. The revised model focuses on the prioritisation of budgets/services by engaging and empowering people living in the localities or across Inverclyde to be involved in decision making at the level where it will have the biggest impact.

5.0 PROPOSALS

- 5.1 The £1million funding will be used to deliver specific actions, initiatives and programmes within Inverclyde's most deprived localities. This will be based on the evidence of need and what will make the biggest difference within the locality areas. The funding will also be used to provide support for people living in low income households or poverty across the community of Inverclyde.
- 5.2 The £1million will be allocated across two broad areas of activity. Firstly, there will be £400,000 of funding available to implement initiatives on an Inverclyde wide basis. These initiatives will be developed by officers and a report will be brought to the next meeting of the Policy and Resources Committee.
- 5.3 Secondly, the most deprived localities will each receive a percentage of £600,000 depending on the levels of multiple deprivation within that locality. It is proposed that the funding be split:

50% - Greenock East & Central

25% - Port Glasgow

25% - Greenock South & South West

This funding will be targeted towards initiatives to address unemployment and employability, support for people experiencing difficulties with alcohol and drugs, people who are classed as homeless and people who are experiencing food insecurities. A schematic of the timescale and processes in relation to the re-invested anti-poverty and multiple deprivation funding is provided in Appendix 1.

- 5.4 The process to tackle poverty and multiple deprivation will build on participatory budgeting and will:
 - Provide the Locality Planning and the associated Communication and Engagement Groups, alongside other existing community groups, with presentations and information from officers on the key challenges that exist within their locality.
 - Officers will provide a range of suggested interventions and people will be encouraged
 to debate on how this funding should be prioritised to make the biggest difference to
 the locality.
 - Members of the groups will be encouraged to participate in the democratic decision making process using voting electronic platforms such as Citizen Space and other physical and electronic means on what interventions they would like in their communities.
 - Once the initiatives have been agreed, both the Locality Planning Groups and the Communication and Engagement groups that exist will continue to be engaged and

- communicated on the development and implementation of initiatives within their community.
- Inverclyde Alliance will receive progress reports on the impact of this proposal through the regular locality planning update process.






