Subject:	APPROVAL TO USE EASTERN SHIRES PURCHASING ORGANISATION		

#### 1.0 PURPOSE

1.1 The purpose of this report is to seek approval to use the Eastern Shires Purchasing Organisation (ESPO) to purchase Pay and Display Machines for the Council's proposed charged car parks.

#### 2.0 SUMMARY

- 2.1 The Council proposes to introduce further charged parking in its car parks in Port Glasgow and Gourock following Environment and Regeneration Committee approval on 28 August 2019. Preparations are also underway to introduce with regard to the Traffic Regulation Order (TRO) to introduce these charges. The planned income from the charged car parks contributes towards the running costs of the DPE scheme.
- 2.2 All the major Pay & Display machine suppliers are already included on the ESPO framework. Savings in procurement costs can be made by using the simplified procurement process which ESPO offers without loss of quality or price competitiveness.
- 2.3 ESPO is a not for profit organisation and can only supply other non-profit and charitable organisations such as local authorities. To enable the Council to utilise the benefits of ESPO, it is required to register as a customer.

#### 3.0 RECOMMENDATION

3.1 That the Committee agrees that the Council should register with ESPO for this immediate procurement requirement and any others which may materialise in future and benefit from this approach.

### 4.0 BACKGROUND

- 4.1 ESPO is a local authority purchasing consortium managed under a Joint Committee by Leicestershire County Council, Lincolnshire County Council, Cambridgeshire County Council, Norfolk County Council, Warwickshire County Council, and Peterborough City Council. ESPO operates within the Local Government Goods and Services legislation as a purchasing agent for its customers.
- 4.2 ESPO is one of the UK's largest public sector professional buying organisations. It operates on a not-for-profit cost recovery basis and is committed to delivering best value to its customers, suppliers and local communities.

Established in 1981 to provide a comprehensive procurement service to the public sector, ESPO has the purchasing power to achieve savings to pass on to customers. The value of ESPO's procurement activity in 2017/18 was £1.7 billion.

- 4.3 ESPO Contract 509 for Parking Management Solutions has a contract period of 4 April 2019 to 31 March 2021.

The type of Contract is a National EU Compliant Framework, Intermediate Contract Management, and covers the supply, installation and commissioning of pay and display machines, including back office IT systems, communications and associated services.
