1.0 PURPOSE AND SUMMARY

- 1.1 ⊠For Decision □For Information/Noting
- 1.2 The purpose of this report is to identify the additional activities that will be launched during Antipoverty week (3-9 October 2022) to support the Inverclyde Community with the cost of living over winter 2022/23, in particular in relation to keeping warm and extending the "Warm Hand of Friendship".
- 1.3 The intention is to provide a directory of warm spaces and warm activities and to work with the third sector and partners to promote these across Inverclyde. Warm boxes will also be provided to those who are most vulnerable through HSCP.
- 1.4 Communities will be encouraged to participate in initiatives and it is proposed that small grants will be made available through CVS for those offering additional activities or support.

2.0 RECOMMENDATIONS

- 2.1 It is recommended that the Policy and Resources Committee note the contents of this report and agree that £100,000 be allocated to CVS to administer a small grants scheme linked to this proposal funded from the unallocated balance in the Anti-Poverty earmarked reserve.
- 2.2 It is recommended that the Committee delegate authority to the Corporate Director of Education Communities & Organisational Development to work with CVS to develop and deliver the grant scheme with an update on progress being included in a report to the next meeting of the Committee.

3.0 BACKGROUND AND CONTEXT

- 3.1 A comprehensive report on anti-poverty interventions already in place to address employment, support for families, food insecurity and financial help is already being considered by the September 2022 meeting of the Policy and Resources Committee. Paragraph 4.12 of this report refers to work being undertaken by the officer group to identify further support for communities, particularly in relation to "warm spaces" and "warm boxes".
- 3.2 Given the national concerns about increasing fuel prices and the cost of living, Council and HSCP officers have worked in partnership with the third sector to promote a joined up approach to supporting communities under the banner of the "Warm Hand of Friendship". The group have looked at good practice from across the country and will launch this initiative during Challenge Poverty week (3-9 October 2022)

4.0 PROPOSALS

- 4.1 The Warm Hand of Friendship aims to provide support to communities but also to encourage communities to work together to help each other during the winter months.
- 4.2 The intention is to create a directory of all the places available to Inverclyde residents across the public, health and voluntary sectors so that anyone who is cold knows where they can go to get warm, stay warm and enjoy a little company and some hot refreshments. Inverclyde Life will also identify activities that are already in place through their directory and can be identified as either warm spaces or warm activities. This makes it easy for members of communities to search through the wide range of activities already taking place.

In addition, library services will increase their offer of activities in order to facilitate and promote libraries as warm spaces during the winter months.

- 4.3 A small grant will be made available to voluntary sectors who wish to offer warm spaces through additional activities during this winter (or activities linked to paragraph 4.4) and this will be administered by CVS Inverclyde. The funding for the grant will be taken from the anti-poverty earmarked reserve and it is anticipated that up to £100,000 will be made available to support initiatives linked to the warm hand of friendship. Further work needs to be undertaken as to the administration of the scheme and the capping of each grant and approval is sought to delegate the finalisation of proposals to the Corporate Director of Education and Communities.
- 4.4 HSCP, subject to IJB approval, will support "Warm boxes" primarily targeted at the elderly and those who receive care at home. Other provisions in place e.g. Inverclyde cares boxes and starter packs boxes will also be enhanced to incorporate items to help with warmth. The cost of the warm boxes will be met by HSCP but will be expected to be in the region of £30,000.

Community organisations may want to adopt the "Warm boxes" initiative or take forward something similar. Many school communities already have uniform banks or clothes shares in place and they may wish to enhance this offer to winter coats and warm leisure wear. The aim of the "Warm Hand of Friendship" is to encourage communities to think about the types of support they can offer and how this might be rolled out. The small grant operated by CVS will also be made available to community groups wishing to seek financial help to provide warm boxes or clothes share initiatives.

4.5 Challenge Poverty Week will also see the launch of other initiatives. This includes the launch of the Food Aid Network information Leaflet and also launch the public consultation of the Financial Inclusion Strategy.
