1.0 PURPOSE AND SUMMARY

- 1.1 ⊠For Decision □For Information/Noting
- 1.2 The purpose of this report is to ask Members of the General Purposes Board to determine the taxi fare scale and charges following the statutory consultation process as part of the Board's annual review. This review has been conducted under section 17 of the Civic Government (Scotland) Act 1982.
- 1.3 There have been no objections or representations received by the Council following the statutory consultation on the proposed taxi fare scale set out in **Appendix 1** which was approved by the General Purposes Board on 22 February 2023.

2.0 RECOMMENDATIONS

2.1 That the Board determine the taxi fare scale and charges following the annual review and that it be remitted to the Head of Legal and Democratic Services to make the necessary arrangements to implement the new taxi fare scales.

3.0 BACKGROUND AND CONTEXT

- 3.1 In terms of Section 17 of the Civic Government (Scotland) Act 1982 (" the 1982 Act ") the Council as Licensing Authority for taxis is obliged to renew and fix scales for the fares, and other charges, within 18 months beginning with the date on which the scales came into effect. Section 17 of the 1982 Act does not apply to Private Hire Cars, although some Private Hire Cars may choose to adopt the Taxi Fare Scale and Charges agreed by the Board.
- 3.2 At its meeting on 9 November 2022 the Board noted that the statutory review of the Council's Taxi Fare Scale and other charges had commenced and that a further report would be submitted to the Board with a note of the outcome.
- 3.3 At a further meeting on 22 February 2023 the Board was advised that the initial consultation process had concluded and that all Taxi Operators, including the Operators Liaison Group and other members of the trade had been consulted and invited to submit their view regarding what they deemed to be the appropriate level of taxi fares in order that any revision of the fare scales could be implemented. The Board, having considered representations, decided to adopt the scale of taxi fares and other charges as set out in the tariff card in **Appendix 1** to this report. The Board decided:
 - that it be remitted to the Head of Legal and Democratic Services to publicly advertise the fare scales as determined by the Board with (a) an increase of 12 % on the flag fall on all 4 tariffs, and (b) a further increase of 12 % on the running mile; and
 - (2) that it be remitted to the Head of Legal and Democratic Services to submit a further report to the Board on the outcome once the statutory period for representations has lapsed.
- 3.4 As part of the Statutory consultation process the proposed revised taxi fare scales were duly advertised on 7 March 2023 with responses due to be submitted to the Council within the statutory period of one month. No objections or representations have been received by the Council to date in relation to the proposed revised taxi fare scale. Should any objections or representations be received before 6 April 2023 copies will be made available to the members of the Board in advance of the hearing on 12 April 2023.

4.0 PROPOSALS

- 4.1 Subject to any appeal against the decision by the Council as licensing authority, it is proposed that arrangements be made for the fare scales to take effect from Sunday 14 May 2023 and to completed by the following Sunday 21 May 2023.
- 4.2 It should be noted that the tariffs set out by the local authority are the maximum fares that may be charged by the operators of taxis within Inverclyde.
- 4.3 The change in taxi meters will be carried out by the normal complement of Council staff in Roads and Environmental Services with the assistance of a representative of the electronic meter company.

For the avoidance of doubt, a vehicle licensed for private hire which uses a taxi meter to charge for journeys is not permitted thereby to pick up hirings from a rank or any public place.

Subject to the consultation process, it is proposed that any new rate of fares and charges be implemented with effect from 14 May 2023.
