#### 292 Police Scotland Performance Report

There was submitted a report on the performance and activities of Police Scotland during the reporting period 1 April 2024 to 28 February 2025, which compared figures with the same period in the previous year. During the course of discussion on this item, reference was made to the Police Estate in Inverclyde. Mr Stewart Taylor, Estates Lead for Police Scotland, provided an overview of the current position in relation to Greenock Police Station. He informed the Panel that Police Scotland is embarking on a significant piece of work following the development of the Estates Masterplan which will detail what is required over the next 10 years to modernise the policing estate and meet the needs of future policing in Greenock and the surrounding communities. Members expressed concerns regarding the 10-year timescale where Inverclyde sits in and the delay in publicising the outcome of the options appraisal that had taken place following the public consultation in March 2024. Mr Taylor answered a number of questions in relation to Members concerns and, he gave his assurance that Inverclyde is a priority and that the Panel would be advised of timelines and proposals for Greenock Police Station. Councillor Reynolds joined the meeting during consideration of this item.

**Decided:** that the information contained in the report be noted.

#### 293 Scottish Fire & Rescue Services Performance Report

There was submitted a report on the performance and activities of the Scottish Fire & Rescue Service during the reporting period Q4 2024/25. During discussion on this item Members expressed concerns about options being proposed to cut services in Inverclyde. Group Commander Anderson provided a summary of proposals namely (1) the permanent removal of an appliance which is already temporarily withdrawn from Invercive and (2) retaining the status quo with modifications to the duty system and crew. He informed the panel that the consultation on the proposals will commence at the end of June and will last for 12 weeks and that members of the public and officers of the Scottish Fire & Rescue Service can participate. It was noted that there will be online and public engagement events taking place to gather feedback from the public. Thereafter Group Commander Anderson answered a number of questions by Members regarding their concerns. It was noted that the Scrutiny Panel will also have the opportunity to respond to the forthcoming consultation. Reference was made to the fire that had occurred recently at Pottery Street, Greenock. Scottish Fire & Rescue representatives were asked if it would be possible to provide an overview of the response to the fire within the report to the next Scrutiny Panel. Thanks were expressed to the emergency workers who were involved in the response to the incident, and this was echoed by the Convenor.

Decided:

(1) that the information contained in the report be noted; and

(2) that it be remitted to Scottish Fire & Rescue Service officers to include an overview of the response to the Pottery Street fire in the report to the next meeting.
