impact of making Kirn Drive in Gourock one-way, as reported to the Committee on 14 March 2024.

Following discussion Councillor Brooks moved the inclusion of a further recommendation, "that the Committee agree to undertake a site visit to Kirn Drive, Gourock at the appropriate time in order to observe the impact of the one-way system."

As an amendment, Councillor McCormick moved the recommendations contained in the report.

Following a roll call vote, 2 Members, Councillors Brooks and Nelson, voted in favour of the motion and 7 Members, Councillors Armstrong, Cassidy, Clocherty, Crowther, Curley, McCormick and Quinn voted in favour of the amendment which was declared carried. Councillor Jackson could not be contacted to vote.

Decided:

- (1) that (a) the outcome of the non-statutory consultation be noted, and (b) it be noted that 75.4% are in favour of a scheme (with a proportion of those in favour requesting additional measures as outlined in paragraph 3.5 of the report);
- (2) that it be noted that the previously considered widening and/or passing places were not taken forward as reported to the Committee in October 2019;
- (3) that (a) the implementation of an Experimental Traffic Regulation Order to enable the experimental implementation of a one-way system (Kirn Drive one-way westbound between Arran Road and Divert Road as well as Staffa Street southbound between Ivy Crescent and Kingsway East), and thereafter the monitoring of traffic flow, be approved;
- (4) that in consideration of the current Scheme of Delegation not authorising officers to make Experimental Traffic Regulation Orders (a) delegated authority be granted to the Head of Physical Assets to carry out the functions of the Road Traffic Regulation Act 1984 under section 9, in relation to the proposed Experimental Traffic Regulation Order, and (b) delegated authority be granted to the Head of Legal, Democratic, Digital & Customer Services to make the Experimental Traffic Regulation Order; and
- (5) that it be noted that 6 months after implementation of the scheme officers will conduct further consultation on the scheme, the outcome of which will be reported to a future meeting of the committee and direction sought on whether to proceed with the making of a permanent Traffic Regulation Order, seek amendments to the scheme or remove the scheme.

Proposed Traffic Regulation Order – The Inverciyde Council Disabled Persons' Parking Places (On-Street) Order No.5 2024

- (3) that delegated authority be granted to the Head of Physical Assets and the Head of Legal, Democratic, Digital & Customer Services to make the necessary arrangements for the public hearing; and
- (4) that it be noted that the cost of appointing an independent Reporter is approximately £5,000, that if required, would be funded from the Decriminalised Parking Enforcement Revenue Budget.

- (2) that (a) the outcome of the common good consultation in relation to a proposed sale of land at Bogston Lane, Greenock be noted, and (b) it be noted that no representations were received either for or against the proposal prior to consideration of the recommendations in the private Property Asset Management report on this agenda; and
- (3) that it be noted that a report on the outcome of an open space consultation in relation to a proposed sale of land to the rear of 54 Cloch Road, Gourock will be brought before this Committee for a decision once the consultation has completed on the 16 May 2025.
