Subject: External Funding Seminar on

local Fund Raising awareness

initiatives

1.0 PURPOSE

1.1 The purpose of this report is for Committee to approve a report on the outcome of the Scottish External Funding Seminar on Friday 5th December 2008 (Committee Report No. RC/CS/033/SJ/WW – 4th September 2008).

1.2 The report will also recommend options to promote and develop the maximisation of external funding into the local Inverclyde economy.

2.0 SUMMARY

- 2.1 The Seminar was organised by the Scottish Local Authority External Funding Officers Group (SLOG), of which Inverclyde Council is a member. The Seminar brought together SLOG representatives from all of the Scottish Local Authorities; representatives from all Scottish CVS's; and was facilitated by representatives from a wide range of Scottish funding bodies (Scottish Funders Forum).
- 2.2 The event had a "Speed Networking" structure, where groups were set up representing regions/areas, e.g., Inverclyde, Renfrewshire, East Renfrewshire, etc, were visited on a 15 minute rotational cycle. This gave SLOG and CVS representatives the opportunity to be aware of various external funding streams and for funders to meet local representatives.
- 2.3 The event was successful in terms of allowing external funding bodies to inform the Inverclyde representative of external funding opportunities. All external funders intimated that Inverclyde is a 'cold spot', and would welcome the opportunity to engage directly in Inverclyde to encourage more grant applications from the area.
- 2.4 The SLOG Annual General Meeting was held in the afternoon. At the AGM, SLOG representatives thanked Inverclyde Council for their hospitality in facilitating their Speed Networking and AGM (see Appendix One).

3.0 RECOMMENDATIONS

- 3.1 That Committee approves the report.
- 3.2 That Committee remits it to the Corporate Director Regeneration and Resources to consider a range of opportunities to raise awareness of external funding to the wider Inverclyde community and voluntary sector.

4.0 BACKGROUND

- 4.1 The Scottish Local Authority External Funding Officers Group (SLOG) comprises one representative from each of Scotland's thirty-two local authorities. The group meets quarterly, with the venues rotating within the member local authority areas. SLOG has representatives on COSLA and the Scottish Funders Forum and has liaison group meetings with the Big Lottery and other funding bodies.
- 4.2 A member of Inverclyde Council's Community Work Team is the SLOG representative for Inverclyde. The information gained through SLOG is shared with the Community Work team, CVS Inverclyde and the Inverclyde External Funding Hub, to raise awareness locally of national funding opportunities for the community and voluntary sector.
- 4.3 A report on the SLOG Speed networking was given to the Inverclyde External Funding Hub. Our Hub has agreed to consider a similar 'Speed networking' initiative for the community and voluntary sector groups in Inverclyde. This initiative would give a wide range of local groups an increased awareness of external funding opportunities. The event would introduce external funding information to local groups. One to one contacts can then be made with funders in the days/weeks after the event. It may be that adjoining neighbourhoods, could work together to deliver local services to their wider areas.
- 4.4 Community Work staff and CVS Inverciyde staff, are working jointly to raise awareness across Inverciyde of individual funding initiatives, meeting the needs of individual neighbourhoods and communities.
- 4.5 Historically a dependency culture has grown around the Inverclyde Council's Grants To Voluntary Organisations. Local groups will automatically apply to the Vol Org grants scheme, without considering external funding options. Through Speed Networking and other initiatives we seek to maximise the income into the Inverclyde economy. These external funding initiatives will go some way to offset some of the pressure placed on the local Grants To Voluntary Organisations budget.
