Subject: Administrative Arrangements: Cycle of Council, Committee and

Board Meetings

1.0 PURPOSE

1.1 The purpose of this report is to set out for approval the schedule of Committee cycles for the period to June 2010.

2.0 SUMMARY

2.1 The proposed cycle of Council/Committee/Board meetings for the period is detailed in the timetable set out in the appendix to the report.

Appendix

- 2.2 The timetable is based on an 8 week cycle for the Strategic Committees, Policy & Resources Committee and the Council. The Planning Board and the General Purposes Board, however, as regulatory committees, have a date set aside each month for the determination of applications and associated business.
- 2.3 The result is two cycles starting towards the end of August and concluding at the start of December and three cycles beginning in early January and concluding with the Council meeting on 9 June 2010.
- 2.4 The timetable runs as follows:-
 - (a) Weeks 1, 5 and 7 in the 8 week cycle have no ordinary meetings arranged for the Tuesday and Thursday of those weeks;
 - (b) The Planning Board will meet on the first Wednesday and the General Purposes Board on the second Wednesday respectively of each month;
 - (c) All ordinary meetings of the Strategic Committees (with the exception of the Education & Lifelong Learning Committee), the Policy & Resources Committee, the Planning Board and the General Purposes Board will normally be held at 3 pm. As agreed by the Council on 28 June 2007, all ordinary meetings of the Education & Lifelong Learning Committee will commence at 4 pm;
 - (d) The ordinary meetings of the Council will take place at 4 pm.

3.0 RECOMMENDATION

3.1 That the Council approve the proposed cycle of Council/Committee/Board meetings for the year to June 2010 as set out in the timetable in the appendix.
