Subject: Strategic Leisure Sites

1.0 PURPOSE

1.1 The purpose of this report is to update Members on the progress to date on the Strategic Leisure Sites programme and provide a revised cost model for year 1.

2.0 SUMMARY

- 2.1 Inverclyde Council, through its budget setting process has allocated £22.7m for a number of sport / leisure sites in Inverclyde with completion by August 2012. The sites identified are, Ravenscraig Stadium, Parklea (Stadium Facility), Parklea (Pavilion), Rankin Park Development, Gourock Park DDA, Gourock Park Amphitheatre, Gourock Pool Upgrade, Pitches Strategy (Priority).
- 2.2 The planned investment indicative profile, which was presented to Council, is contained in Appendix 1.
- 2.3 Officers have met regularly to develop each of the distinct projects and these are currently at different stages dependant on the timescales which prevail. Appendix 2 provides members with detail on each of the projects.
- 2.4 A number of meetings have been held with Sportscotland to make them aware of the Council's commitment to key leisure sites and they have been supportive of our proposals.
- 2.5 Property Resources and Facilities Management have developed their framework of Consultant appointments and have formally appointed consultants where it is considered appropriate not to complete the design works in house.

3.0 RECOMMENDATION

- 3.1 That members note the position in relation to progress of the projects.
- 3.2 That Committee approves the allocation of funds to pitches contained in para 4.4 below within the approved budget and agrees to the re-profile of the indicative profile in Appendix 1.
- 3.2 That the Committee delegates authority to the Corporate Director Regeneration & Resources to select appropriate tenderers and issue tender documents for the delivery of the:-
 - track and stadium upgrade and associated shielding works and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General) and Financial Regulations (26.5) and European Procurement Directives for the Ravenscraig stadium proposal.

- 1st synthetic football pitch and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General) and Financial Regulations (26.5) for the Parklea enabling works.
- community stadium, pavilion, drainage improvements and associated infrastructure works and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General), Financial Regulations (26.5) and European Procurement Directives, for the main Parklea works.
- sport centre, pitches, drainage improvements and associated infrastructure works and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General), Financial Regulations (26.5) and European Procurement Directives, for the Rankine Park works.
- upgrade and development improvements and associated infrastructure works and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General), Financial Regulations (26.5) and European Procurement Directives, for the Gourock Park amphitheatre works.
- upgrade and development improvements and associated infrastructure works and accept the lowest or most economically advantageous tender in accordance with Council Standing Orders (General), Financial Regulations (26.5) and European Procurement Directives, for the Gourock Pool works.
- 3.3 The Committee remit that the Corporate Director Regeneration and Resources present 6 monthly update reports on the programmes delivery.

4.0 BACKGROUND

- 4.1 Inverclyde Council, through it's budget setting process has allocated £22.7m for a number of sport / leisure sites in Inverclyde with completion by August 2012. The sites identified are, Ravenscraig Stadium, Parklea (Stadium Facility), Parklea (Pavilion), Rankin Park Development, Gourock Park DDA, Gourock Park Amphitheatre, Gourock Pool Upgrade, Pitches Strategy (Priority).
- 4.2 The allocation of funds to projects was developed through a number of reports, including the strategic sites review and the pitches strategy document, which have previously been presented to Committee.
- 4.3 The proposed allocation of funds (£3m) for pitch redevelopment is in line with the pitches strategy in consultation with Sportscotland. Consideration has been taken in respect of location, use, surface, changing accommodation, drainage and proximity to other facilities, including available schools. Officers considered every pitch in the area and the following is proposed:- Parklea 3g £642k, Parklea drainage £906k, Broomhill pitch £500k, Broomhill pavilion £200k, George Road £500k, Birkmyre £140k, a balance of £112k will be used for contingencies.
- 4.4 The blaes pitches at Greenock High School were considered on this list due to the memorandum of understanding between the Council and Sportscotland in relation to Inverclyde Academy. A proposal to upgrade the unseeded pitch at Inverclyde Academy to 3g has been discussed with Sportscotland. Sportscotland is amenable to this proposal and have stated that they are prepared to waive the planning constraints in respect of the Greenock High School site. This results in a substantial windfall for the Council as it is benefitting from an additional capital receipt in due course as well as removing the requirement for upgrade of the blaes pitches.
- 4.5 Members will be aware from the report presented to the March 2009 Committee that £450,000 was allocated to be brought forward within the strategic sites programme as a result of the Scottish Government's initiative on capital spending. This brings the year one spend to £1.775m. The proposed spending allocation this financial year is:-
