There was submitted a report by the Head of Legal & Democratic Services on an application for a Street Trader's Licence by Mr Archibald Wilson to operate a moveable stall at the east end of the car park at Lyle Hill, Greenock following receipt of a public objection and concerns raised by Councillor McCallum. At its meeting on 9 February 2011 the Board decided to continue the application to a further meeting to allow Mr Wilson to seek legal advice and to amend the application form as appropriate.
