## 1.0 PURPOSE

1.1 The purpose of this report is to set out for approval the schedule of Committee cycles for the period to June 2012.

## 2.0 SUMMARY

2.1 The proposed cycle of Council/Committee/Board meetings for the period is detailed in the timetable set out in the appendix to the report.

Appendix

- 2.2 The timetable, with the exception noted below, is based on an 8 week cycle for the Strategic Committees, Policy & Resources Committee and the Council. The Planning Board and the General Purposes Board, however, as regulatory committees, have a date set aside each month for the determination of applications and associated business.
- 2.3 The result is two cycles starting towards the end of August and concluding at the start of December and two cycles beginning in mid January and concluding with the Council meeting on 12 April 2012.
- 2.4 Additionally, as last year, it is proposed to hold a meeting of the Policy and Resources Committee on Tuesday 16 August 2011 to deal with any items of business requiring consideration during the summer recess period.
- 2.5 The timetable runs as follows:-
  - (a) Weeks 1, 5 and 7 in the 8 week cycle have no ordinary meetings arranged for the Tuesday and Thursday of those weeks;
  - (b) The Planning Board will meet on the first Wednesday and the General Purposes Board on the second Wednesday respectively of each month;
  - (c) All ordinary meetings of the Strategic Committees (with the exception of the Education & Lifelong Learning Committee), the CHCP Sub-Committee, the Policy & Resources Committee, the Planning Board and the General Purposes Board will normally be held at 3 pm. As agreed by the Council on 28 June 2007, all ordinary meetings of the Education & Lifelong Learning Committee will commence at 4 pm;
  - (d) The ordinary meetings of the Council will take place at 4 pm.
- 2.6 As Members will be aware, in terms of Standing Orders, the Health and Social Care Committee requires to sit once a year (on a date to be determined by the Convener in agreement with the Members of the CHCP Sub-Committee) with the CHCP Sub-Committee sitting on all other occasions which would ordinarily have been a sitting of the Health and Social Care Committee. The Sub-Committee agreed at its last meeting that the annual meeting of the Health and Social Care Committee in 2011 should be in August which, on the basis of the timetable, would be on 25 August 2011.

- 2.7 The Council elections are presently set for 3 May 2012, being the first Thursday in May. The statutory meeting of the new Council following these elections must take place in terms of the Local Government etc (Scotland) Act 1994 and the Council's Standing Orders within 21 days of the day of the election. Following the last election on 3 May 2007, the statutory meeting was held on 24 May.
- 2.8 At a similar point in the Council's life in 2006, the Council agreed to provide for one cycle to be arranged between the statutory meeting and the summer recess on the basis that a new administration would be unlikely to effect changes to the political management arrangements prior to the summer recess.
- 2.9 This final cycle is a compressed cycle ending with a meeting of the Council in June. It is, of course, not possible at this stage to fix dates for the pre-agenda meetings in this cycle.

## 3.0 RECOMMENDATION

3.1 That the Council approve the proposed cycle of Council/Committee/Board meetings for the year to June 2012 as set out in the timetable in the appendix.
